Characteristics of the unit:	<p>Mikolajki Commune - a unit of local self-government established under Resolution No. XXI/83/72 of the Provincial National Council in Olsztyn of December 6, 1972 on the establishment of communes in the Olsztyn province. Pursuant to Article 101 (1) of the Act of January 25, 1958 on National Councils (Journal of Laws of 1972, No. 49, item. 314), the Provincial National Council in Olsztyn enacted in the County of Mrągowo /former Olsztyn Province/ the municipality of Mikołajki, which included the areas of the following sołectowns: Baranowo, Cudnoch, Faszcz, Górkło, Grabówka, Inulec, Jora Wielka, Lubiewo, Olszewo, Prawdowo, Sady, Tałty, Woźnice, Zełwagi.</p> <p>All procedures in the municipality are subject to the rigors of current legislation and are supervised by the Municipal Council, the Audit Committee of the Municipal Council and the Regional Chamber of Accounts. The legal status of the Municipality of Mikolajki is regulated by the Law of March 8, 1990 on municipal self-government /Journal of Laws 01.142.1591/.</p> <p>According to this Act, the Municipality has legal personality and performs public tasks on its own behalf and on its own responsibility.</p> <p>The regime of the municipality is determined by its statute. The Statute of the Municipality of Mikolajki was approved by the Municipal Council of Mikolajki by Resolution No. XVII/63/2020, adopted at a session on June 30, 2020 /announced in the Official Gazette of the Warmińsko-Mazurskie Voivodeship of August 18, 2020, item 3454/.</p> <p>According to the Statute, the scope of the Municipality's activities is to meet the collective needs of the local government community, to create conditions for the rational, harmonious, economic and social development of the Municipality, and to organize public life in its territory.</p>
